Snowy Range Ski Club RELEASE OF LIABILITY AND INDEMNITY AGREEMENT AND CONSENT FOR MEDICAL TREATMENT

PLEASE READCAREFULLY BEFORE SIGNING THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS

"ADULT" means the undersigned adult Participant, being at least 18 years old, signing on behalf of himself / herself and /or the undersigned parents) or legal guardian(s), being at least I8 years old signing on behalf of the minor child named below so that the child will be permitted to engage in an ACTIVITY. "CHILD" means the minor child Participant named below. ADULT and CHILD shall collectively be referred to hereinafter as "PARTICIPANT". PARTICIPANT agrees and understands that skiing strength and endurance training and/or any other uses of the facilities, activities or equipment of ski areas can be HAZARDOUS. ADULT agrees and understands that without ADULT'S signature on behalf of the CHILD that binds CHILD to the terms of this agreement CHILD will not be permitted to engage in the ACTIVITY.

PARTICIPANT UNDERSTANDS AND AGREES TIIAT THIS FULL AND COMPLETE RELEASE OF LIABILITY AND INDEMNITY AGREEMENT AND CONSENT WILL APPLY FOR EACH AND EVERY DAY THE PARTICIPANT ENGAGES IN ANY ACTIVITY, DURING THE SKI SEASON without requiring PARTICIPANT to sign an additional form for each day and/or each ACTIVITY.

As a PARTICIPANT in the Snowy Range Ski Club program PARTICIPANT will be involved in ski club and performance of skiing. PARTICIPANT recognizes, understands and agrees that participation in such programs is a hazardous and dangerous activity. The UNDERSIGNED further agrees that as a PARTICIPANT in a ski club or performance program, PARTICIPANT is a competitor at all times, whether practicing for competition or in competition. PARTICIPANT understands that he/she has the opportunity to and Will make a reasonable visual inspection of the event 'course prior to participating in an event and that he/she assumes the risk of all course conditions, including but not limited to course construction, configuration, layout. obstacles, weather, and snow conditions. As a Snowy Range Ski Club participant. PARTICIPANT may be involved in travel to and from events over snow or ice covered roads in inclement weather and accepts such risks. ADULT agrees and understands that CHILD will be using ski lifts without a ski instructor. SRRT representative, or other adult present. Participation in the Snowy Range Ski Club program shall not in any way eliminate the inherent risks of skiing or risks involved in riding ski lifts.

RECOGNZING AND ACCEPTING THE ABOVE RISKS AND RESPONSIBILITIES, ADULT VOLUNTARILY CHOOSES TO TAKE PART IN THE RACINGOR PERFORMANCE PROGRAM OR VOLUNTARILY CHOOSES TO ALLOW CHILD TO TAKE PART IN THE RACING OR PERFORMANCE PROGRAM.

PARTICIPANT agrees to read and obey all posted signs and warnings and to obey signs and warnings located at any facility or premise of the Snowy Range Ski Area Resort or any other venue. PARTICIPANT understands that entering or skiing in a "CLOSED" area is illegal.

PARTICIPANT agrees to respect all equipment before use and ask questions of SRRT representatives if PARTICIPANT does not fully understand how to use the equipment ADULT hereby for him / herself and, if applicable, on CHILD'S behalf, assumes all risks associated with participation in an ACTIVITY known or unknown inherent or otherwise, including but not limited to, injury and/or death to the PARTICIPANT, and HEREBY RELEASES on his/her own and CHILD'S behalf Snowy Range Race Team coaches, representatives, and volunteers. (Here in after the "released parties") from ANY AND ALL LIABILITY and/or claims that the undersigned ADULT or CHILD may be entitled to bring on his / her own behalf or that might be brought on behalf of CHILD that arise from the ADULT'S or CHILD'S participation in an ACTIVITY including travel to and from events away from the Snowy Range Ski Area 'Resort, and including claims based he/she AGREES TO INDEMNIFY ADULT and /or CHILD arising in on negligence or breach of warrant," PARTICIPANT represents that and hold harmless the Released Parties from any and all claims of the whole or in part from the ADULT'S or the CHILD'S participation in an ACTIVITY ADULT warrants that the party engaging in the ACTIVITY is in good health and there are

no special problems with the care of the party engaging in the ACTIVITY and that the ADULT has left no special instructions regarding the care for-SUCH PARW that have not been provided to the RELEASED PARTIES in writing.

PARTICIPANT understands that additional fees may be required for use of some facilities or equipment, ski instruction, or other services provided by the RELEASED PARTIES.

PARTICIPANT authorizes the RELEASED PARTIES and /or their authorized personnel to call for medical care for PARTICIPANT and to transport PARTICIPANT to a medical facility

Or hospital if in the opinion of such personnel, medical attention is needed. PARICIPANT agrees that upon PARTICIPANT'S transport to any such medical facility or hospital that the RELEASED PARTIES shall not have any further responsibility for PARTICIPANT. Further, PARTICIPANT agrees to pay all costs associated with such medical care and related transportation provided for PARTICIPANT and shall indemnify and hold harmless the RELEASED PARTIES from any costs incurred therein.

In consideration for participating in an ACTIVITY, PARTICIPANT aggress that ALL claims for injury, property damage, and/or death arising from the ADULT'S and/or CHILD'S participation in the ACTIVITY shall be GOVERNED BY \TVYOMING LAW without reference to any choice of law rules and EXCLUSTVE JURISDICTION shall be. in the District Court for Albany County, Wyoming or in Federal Court for the District of Wyoming

This Release shall be binding to the fullest extent permitted by law. If any provision of this Release is found to be unenforceable the remaining terms shall be enforceable. The Under Signed parent of legal guardian acknowledges and agrees that he/she is also signing this Release on behalf of the CHILD and that the CHILD will be bound by all the terms of this Release. This Release shall be binding upon PARTICIPANT'S assignees, subrogors, distributors, heirs, next of kin, executors and personal representatives.

PARTICIPANT HAS CAREFULLY READ THIS AGREEMENT, UNDERSTANDS ITS CONTENTS AND SIGNS IT WITH FULL KNOWLEDGE OF.1TS SIGNIFICANCE.
